Artist & Fine Crafter Information Sheet

You are cordially invited to submit an entry into the 29th Annual Art in the Park. Art in the Park is held each year in the beautiful Lincoln County Courthouse Lawn in Shoshone, Idaho! This arts & fine crafts festival is heavily promoted by both local and state media. Each year this event continues to grown in popularity and quality -making a “must do” on your summer event calendar!

- Artist Amenities include curb-side assistance with unloading, booth sitters, artist welcome package and more.
- All artists and fine crafters in all media and categories are welcome to apply. To ensure the quality of the show all work must be designed and executed by the accepted artist or fine crafters.
- **ONLY ORIGINAL HAND-CRAFTED WORK!** No imports, kits, items made from kits are allowed. **No buy/sell—this harms the quality of the show!**
- Artwork must be in good taste and mindful of the show/s intent and community’s standards
- To further guarantee a quality show, nothing of lesser quality or completely different style than that which is clearly visible in the jury process may be exhibited and/or sold. Art in the Park reserves the right to refuse exhibition and/or sale of work not consistent with submitted images.
- Booth space is approximately 12 x 12 - Remember, this is a park and trees and other landscaping will change from year to year.
- Stakes are allowed to be used. Please be aware of sprinkler lines.
- We do not provide electricity to arts and fine craft vendors. Power available to only food vendors.
- Artists should be set up Friday afternoon/evening or very early Saturday morning.
- Security is included both Friday and Saturday evenings
- Please do not bring pets to the show.

Artist & Fine Crafter Application Procedures

- (1) **Complete the attached Artist & Fine Crafter Application; including signature.**
- (2) **Submit four (4) images** - Three (3) of your work and one (1) of your show display with current work; representative of your overall presentation. Images must be of work executed within. Digital images (jpeg format preferred) can be emailed along with application to LincolnCoChamber@gmail.com or photographs (no larger than 4 x 6) can be mailed to our 102 South Rail Street East address. Please submit **ONLY** four (4) images as described above. No brochures, fliers, etc.
- (3) **Submit Booth Fee of \$75.00 East side Space, \$55.00 West Side Space, \$75.00 Food Vendor, \$20.00 Non-Profit Organization.** Payments are to be submitted with checks made payable to **Lincoln County Chamber of Commerce**. Booth fees for accepted artists will not be processed until the artist has been notified. Accepted artist booth fees are non-refundable. All Booth Fees paid for by check will be returned via mail if not accepted (along with any photographs, if applicable) Booth fees by credit card for artists not accepted will not be processed.
- (4) MasterCard, VISA, Discover, and American Express are welcome. Please provide all required/requested information on the application. There are no refunds of booth fees after acceptance and a \$35.00 returned check fee will apply.

APPLICATION DEADLINE: All materials must be received by **July 1st, 2016**. No refunds of Booth Fees after acceptance.

EARLY REGISTRATION: If you register **before May 15, 2016** you will receive a \$10.00 off of your vendor space.

ARTISTS NOTIFICATIONS: Artists will either be notified by postal mail or email of acceptance.

Further detailed information will be provided to artists and fine crafters with acceptance letters.
