## 2023 RULES & REGULATIONS

(Please keep this page for your records)

1. All applicants must submit the following: 3 images of artwork and 1 image of your booth display. If you do not have a photo of your booth, please submit a drawing with a detailed description of your setup. Write your name on each photo or cd.
2. Include a self-addressed stamped envelope, which is the appropriate size for your photos or CD if you want them return to you.
3. Shoshone Arts In the Park will be held on July 8 & 9, 2023 (regardless of the weather.)
4. All work exhibited must be original and handcrafted by the artist. The limited use of manufactured items will be allowed, only if incidental to the final product and included in your photos.
5. Artist must be present with their work for the entire event.
6. Booth fee is \$95.00 East side / \$85.00 West side per 12x12 booth. Make all checks payable to Shoshone Chamber. Your booth fee will NOT be deposited unless you are accepted. If you are accepted your check will be cashed. Booth fee must be paid in full before setup of your space.
7. All applicants will receive notification of show status by June 30, 2023. If you apply online you will receive notification via email. If you mail your application you will receive notification by mail. If you haven't received notification by the above date please contact our office as soon as possible.
8. There will be NO refunds after the notification date of June 30, 2023. Cancellations after this date are non-refundable. No refunds will be given due to the cancellation of the event by, an act of God, local authorities, or a weather related incident.
9. Please provide us with your Idaho Sales Tax I.D. Number. To acquire a number contact the Idaho State Tax Commission at (208) 334-7660. If you are from out of state, or only plan to do a few shows in Idaho, a Concessionaires form may be sufficient for you. Forms are available at [tax.idaho.gov/taxes/sales-use/permits/temporary-sellers-permits](http://tax.idaho.gov/taxes/sales-use/permits/temporary-sellers-permits). When registering, please use the Shoshone Arts Event ID: 1042415616 Please be advised that the Tax Commission may collect onsite.
10. Absolutely all inventory, boxes, artwork, etc. must be contained within your booth space and can not interfere with adjacent exhibits or walkways in anyway.
11. Artists are responsible for their own property and for furnishing their own tents, tables, chairs, and change. Artists are responsible for insurance and protection of artwork and display. Shoshone Arts In The Park will not be responsible for damage to artwork or display.
12. Law Enforcement will be walking through the event and Emergency Medical Services will be on the grounds also.
13. Exhibitors agree to conduct themselves in a respectful, cooperative manner. Any behavior deemed inappropriate by Shoshone Arts in the Park/Shoshone Chamber of Commerce may result in expulsion. Shoshone Arts in the Park is a family friendly event and does not wish to include radical, disturbing displays or outbursts at this event.
14. Violation of any of these rules is basis for expulsion.
